

Lodge Dinner Held in Ukiah Cabrosha Chapter Hosts Event

About 90 arrowmen from around the Lodge gathered at the Broiler Steakhouse north of Ukiah on Saturday, November 17, 2001 for the annual lodge dinner. The evening was packed with fellowship, awards, and inductions, as the year was brought to a close. A highlight of the evening was the feature of the *Bald Eagle Award*, presented to Orca Lodge at the W-3B Conclave in Redding. **Lodge Chief Michael Buxton** promised to return the award to Orca again the following year.

After dinner, special recognition was accorded those arrowmen who have made distinguished contributions to either the lodge, the council, or Scouting as a whole. The *Vigil Honor* was bestowed on six arrowmen this year in recognition of their exemplary cheerful service and their demonstration of the principles of Scouting. **Scott Alto, Andrew Bulleri, Michael Buxton, Tim Bradford, Kevin Hamblin, and Mike O'Neill** were recognized as the Lodge's Vigil candidates.

Next, *Silver Fluke* awards were presented. The *Silver Fluke* is a special award given by the Lodge to recognize those arrowmen who have demonstrated unselfish service to the lodge. The award features a silver arrow with an Orca fluke engraved in the center. The initials of the recipient are etched on the reverse of the pin. **Jason Kracht, Ken Moffitt, and Chris Schoenthal** were awarded the fluke this year to honor their dedicated service.

Orca Lodge also presented two *Founder's Awards* this year. This award is given in recognition of outstanding service to the lodge and to those who have demonstrated the principles of brotherhood, cheerfulness, and service to an exceptional degree. **Dave Dukeman and Michael Komorowski** were this year's recipients.

Also during the course of the dinner, youth arrowmen

had the opportunity to vote for new officers. The results were announced toward the end of the dinner and the new slate of officers was sworn in by **Chris Schoenthal, Section Vice Chief of Operations.** It was also

announced that **Dave Dukeman**

would replace **Greg Hannan**, who stepped down after three years of service, as Lodge Adviser. In addition to **Dukeman**, the 2002 lodge officers are: **Michael Buxton**,

Lodge Chief, Chris Faurot, Lodge Vice Chief, John Mattern, Lodge Secretary, and Joey Fini, Lodge Treasurer.

The lodge also had the special opportunity to witness **Jason Kracht's** induction into the *Wood Badge* program. In a Court of Honor led by **Dan Ramos**, **Kracht** was recognized with the *Wood Badge* scarf and beads.

To close the evening, Jason Yarnall tried his hand as an auctioneer, successfully collecting \$170 from Greg Hannan for the prototype of the recently-produced Lodge chenille. The prototype featured a black border, instead of the blue border that the regular issue chenille bears and was the only such patch issued. By order of the Lodge Executive Committee, it is not an official lodge issue (so

no, you don't have to have this patch to acquire a complete lodge set). The regular issue lodge chenilles were distributed at the end of the evening to those who had preordered.

Arrowman Service Award



The Order of the Arrow's vision for the future emphasizes a strategy of increased service to the Boy Scouts of America by Arrowmen. To reward those Arrowmen who go beyond their immediate responsibilities to help and guide others to new heights, the Order of the Arrow creat-

ed the *Arrowman Service Award*. The award will focus on three areas of service: personal, chapter/lodge activities, and general service to the community.

The timeline of the award will begin on January 1, 2001, and will end on December 31, 2003. The award may be earned in the year 2001, 2002, and 2003. All first time recipients may purchase the original award (the white ribbon with the gold compass). Arrowmen who earn the award more than once during the outlined three year period (2001-2003) may purchase the silver attachment for having completed this award a second time (2002 or 2003 only) and the bronze attachment for having completed this award a third time (2003 only). The attachment will be worn on the award's white ribbon. Signatures of approval will be required for each requirement.

NOAC 2002: 6 Days of OA Fellowship

The National Order of the Arrow Conference—NOAC—will be held from July 27 to August 1 of this year. The conference is a biannual gathering of arrowmen from across the United States. NOAC is an event that includes training, fellowship, and activities for arrowmen. The conference will be held in Bloomington, Indiana, on the Indiana University Campus, with the theme of "Test Yourself and So Discover." As an additional perk, all dorm rooms at Indiana University now have air conditioning (so you might only have to take two showers a day).

Orca Lodge will be sending a contingent to NOAC this year. If you are interested in attending the conference, you must have your paperwork submitted no later than Friday, February 22, 2002. In addition, you must also enclose a check for



\$250 (see application form). Of this first payment, \$100 will be sent to the National Order of the Arrow Director as a deposit. This deposit is nonrefundable. The cost for attending the conference is \$305 for both youth and adult arrowmen. The lodge has estimated that the total cost will be approximately \$750 for each contingent member. This includes the previously-mentioned conference fee (covers housing, meals, program fees), as well as round-trip airfare and transportation from the airport to the conference. A second payment of \$250 is due by April 15, and the final payment of \$250 is due by June 1. If the total costs of the trip are less than this estimated amount, the balance will be refunded; if it costs more, those who have registered will be notified.

A preliminary sign-up sheet was passed around at the Lodge Dinner in November. Those who signed up should have received this article and registration form in the mail already. If you did not get a chance to submit your name and would like to go, or did submit your name, but did not receive the registration form by mail, please contact either *Lodge Adviser* **Dave Dukeman at 443-9559 or quietleder@aol.com** or *Lodge Chief* **Michael Buxton at 578-5552 or byebux@aol.com**, so that your space can be assured. Because of national quotas, Orca Lodge can only send one adult per two youth members who sign up. Currently the lodge is looking for additional youth members who wish to go.
